Cofnodion o gyfarfod o'r Cyngor a gynhaliwyd Nos Lun y 13eg o Dachwedd 2023 am 7.00yh yn y Ganolfan, Abergynolwyn.

Presennol; Cyng. Emrys Thompson, Elwyn Evans, Robert D Jones, Gwynedd Roberts, Eleri Puw, Steve Lewis, Dylan Jarman, Miriam Webb, Bethan Lawton (Cyngor Gwynedd) a Huw T Jones (Clerc)

1. Estynwyd groeso cynnes i bawb gan y Cadeirydd Emrys Thompson.

Ar ddechrau'r cyfarfod, croesawyd Jane a John Barraclough i son am y diweddaraf gyda Ysbyty Tywyn. Roeddynt yn mynd oddiamgylch Cyngorau Cymuned i gael cefnogaeth i'r ysbyty, yn bennaf i ail agor y ward gleifion yno, a chael cyhoedduswydd i Gyfarfod Cyhoeddus yn Neuadd Ysgol Uwchradd Tywyn ar yr 21ain o Dachwedd. Dosbarthwyd daflenni i bawb. Byddai prif swyddogion Bwrdd Iechyd Betsi Cadwaladr yno, ynghyd a Geoff Ryall- Harvey, Cyfarwyddwr Rhanbarthol, Llais Cymru. Trafodwyd materion megis y trafferth i ricriwtio staff, prinder tai i weithwyr, beth fyddai'r galw yn y pen draw, y cynllun 'Tuag Adre', a'r ffaith fod BCUHB mewn mesurau arbennig. Diolchwyd yn fawr iddynt am ddod atom.

Yn dilyn trafodaeth, ar gynnig Cyng Robert Jones a'l eilio gan Cyng. Elwyn Evans, a gyda chefnogaeth pawb, cytunwyd I'w rhoi ar y wefan, ond i'w hadolygu yn y Cyfarfod Blynnyddol yn 2025. Nodwyd y gellid newid unrhyw fanylion eto.**

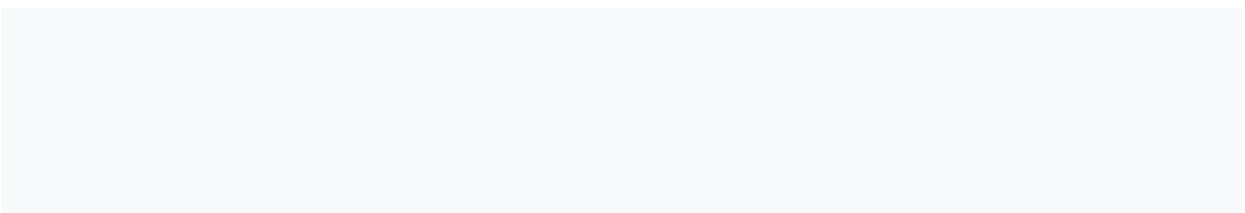
b) Nodwyd y gohebiaeth a ganlyn, a byddai'r Clerc y neu danfon oddiamgylch;

LLANFIHANGEL Y PENNANT COMMUNITY COUNCIL

Minutes of a Council meeting held on Monday evening the 13th of November 2023 at 7.00pm at the Ganolfan, Abergynolwyn.

Present; Cllrs. Emrys Thompson, Elwyn Evans, Robert D Jones, Gwynedd Roberts, Eleri Puw, Steve Lewis, Dylan Jarman, Miriam Webb, Bethan Lawton (Gwynedd Council) and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Emrys Thompson.

At the start of the meeting, Jane and John Barraclough were welcomed to talk about the latest with Ysbyty Tywyn. They were going around Community Councils to get support for the hospital, mainly to re-open the patient ward there, and get publicity for a Public Meeting in the Tywyn High School Hall on the 21st of November. Leaflets were distributed to everyone. Betsi Cadwaladr Health Board chief officers would be there, along with Geoff Ryall-Harvey, Regional Director, Llais Cymru. Issues such as the difficulty in recruiting staff, shortage of housing for workers, what the demand would be in the end, the 'Tuag Adre' scheme, and the fact that BCUHB is in special measures were discussed. They were thanked for coming to the meeting.

2. Declarations of interest were invited for issues on the agenda, but no declarations were received.

It was noted that there was no request to have presentations from members of the public on an issue on the Agenda.

3. The minutes of the meeting held on the 9th of October were confirmed on the proposal of Cllr Eleri Puw and seconded by Cllr Elwyn Evans.

4. Matters arising

- a) Cutting the grass of cemeteries and the playing field - a draft advertisement that had been prepared by the Clerk was noted, and this was agreed. The advertisement would need to be placed in Dail Dysynni, and Cllr Beth Lawton said she would help put it on local organizations' facebook. The Clerk and the Chairman would visit the site with those who expressed an interest.
- b) Painting work on equipment in the Playground - the Clerk had contacted the 3 names once again to ask for a price, but only one estimate was to hand, that of Luke Genders, and this was agreed to. The price was £750 for labour (5 days work), and £200 for the paint. The Clerk was asked to contact him to confirm, and to start the work around Easter 2024.
- c) Talylyn Railway - the latest was noted with having a slate wagon on the outskirts of the village, and that money would be needed through a slate project. We needed to get a price from Liz Porrett, and then invite her to meet us.
- d) Tree damaging a wall - there was no update.
- e) Website for the Council - the Clerk was thanked for the work, and everyone was very happy with the content
- f) Heritage Site - it was reported that a meeting was held over zoom, and that there was a search for projects.
- g) Dog poo bin - noted that this has been resolved.
- h) Councilor Training - the latest courses were outlined, and what was available free of charge for Councillors. Cllr Miriam Webb and Robert Jones agreed to go on the course on the code of conduct Module 9 which was to be held on the 22nd of November. The Clerk would arrange this.
- i) Policies to be adopted before putting them on the website - it was reported that the following policies had been sent out to everyone in advance, namely Equal Opportunity, Freedom of Information, Environmental, Information and Data Protection, together with a Concerns and Complaints policy. Following discussion, on the proposal of Cllr Robert Jones and seconded by Cllr. Elwyn Evans, and with everyone's support, it was agreed to be put on the website, but to be reviewed at the Annual Meeting in 2025. It was noted that any details could be changed again.

5. Planning Matters

There were no applications received since the last meeting.

6. Finance Matters.

It was decided to pay the following;

H G Web Designs invoice - new website design - £310.

Gwynedd Council invoice for internal audit - £318.

There was a request for money from Radio Ysbyty Gwynedd and it was decided not to contribute.

A draft budget prepared by the Clerk was noted ready for discussion next time regarding the level of the precept for 2024-25. It would be circulated before the next meeting. It was noted that the Council keeps money in reserve for improvements to the playground.

7. Councilor Beth Lawton's report (Gwynedd Council)

The work and meetings of the Health Board were reported, and also a consultation with the Air Ambulance.

It was noted that there was a possibility of huge cuts in the Gwynedd Council budget in the next year.

Arrangements were noted with the Christmas Tree in Abergynolwyn for 10th December.

8..Cllr.'s Report. Elwyn Evans, representative of One Voice Wales.

There was no report this time.

9. Correspondence.

a) Matters of Llanfihangel y Pennant cemetery

- An email was received from Benjamin Thomas, Aftercare Funeral Services, Tywyn, that the ashes of the late Suzanne Llywarch were buried 13/11/23. A payment of £100 was confirmed to open a grave this time, In the future, it was seen that Richard Griffiths should be used to open graves for cremated remains, and that it is up to the Community Council who opens graves.
- Correspondence was noted confirming that the ashes of the late William Davies would be buried in the family grave on Saturday 9th December. A cheque had already been received for £722

10. Any other matter

- Cllr Gwynedd Roberts continued to cut brambles/growth around salt bins as usual, and this was very much appreciated.
- It was necessary to ensure that the salt bins were full for the winter, and the Clerk would contact the Highways Department of Gwynedd Council.
- A hedge was overgrowing on Llanegryn Road, and obstructing those who walk the pavement which could be dangerous.
- All the Councilors confirmed that they will claim the usual remuneration before the end of the financial year. The Clerk would prepare the cheques by the next meeting.
