### Cofnodion o gyfarfod o'r Cyngor a gynhaliwyd Nos Lun yr 8fed o Ebrill 2024 am 7.00yh yn y Ganolfan, Abergynolwyn.

Presennol; Cyng. Emrys Thompson, Elwyn Evans, Robert D Jones, Gwynedd Roberts, Steve Lewis, Eleri Puw, Miriam Webb, Bethan Lawton (Cyngor Gwynedd) a Huw T Jones (Clerc)

1. Estynwyd groeso cynnes i bawb gan y Cadeirydd Emrys Thompson. Roedd ymddiheuriadau i law gan Cyng Dylan Jarman.
2. Gwahoddwyd ddatganiadau o ddidordeb am faterion ar yr agenda, a nododd Cyng Robert Jones ddiddordeb yn y cais gan Glybiau Ffermwyr Ieuainc Meirionnydd. Nodwyd nad oedd unrhyw gais i gael cyflwyniadau gan aelodau o'r cyhoedd ar fater ar yr Agenda.
3. **Cadarnhawyd gofnodion y cyfarfod a gynhaliwyd ar yr 11eg o Fawrth** ar gynnig Cyng. Gwynedd Roberts a'l eilio gan Cyng Eleri Puw.

#### 4. Materion yn codi

- a) **Materion Prifyrdd/llwybrau** – cyfeiriwyd at y gwrych a oedd yn gor-dyfu ar Heol Llanegryn, a bod cadarnhad fod Cyngor Gwynedd wedi ysgrifennu eto at berchennog rhif 6.

Trafodwyd y syniad o wneud llwybr o giat Heol y Dwr i fynny at fainc yn y Cae chwarae. Roedd Rheilffordd Talyllyn wedi cynnig y byddent yn helpu gyda'r gost. Penderfynwyd, yn dilyn pleidlais, i ofyn am bris i gael syniad o'r gost yn y lle cyntaf. Byddai'r Clerc yn cael gair gyda G L Jones, Playgrounds, Bethesda.
- b) **Rheilffordd Talyllyn** – yng nghyswilt y prosiect wagen lechi, darllenwyd ymateb Anna Lewis o Gyngor Gwynedd oedd yn dweud y gellid gwneud cais o dan gynllun LleCHI LleNi - cais y loteri. Byddent yn gwybod a yw'r cais loteri yn llwyddiannus erbyn diwedd Mehefin. b) Ceisiadau am arian;

Trafodwyd llythyr **Clybiau Ffermwyr leuainc Meirionnydd**, ynghyd a'r fantolen oedd wedi ei danfon I'r Cyngorwyr. Yn dilyn pleidlais, cytunwyd, ar gynnig Cyng Gwynedd Roberts a'l eilio gan Eleri Puw i **gyfrannu £100**. (cafwyd datganiad diddordeb gan Cyng Robert D Jones pan drafodwyd hyn, ac roedd wedi arwyddo y ffurflen)

c) Amlinellwyd y gohebiaeth gan Archwilio Cymru am archwiliad 2023-24, yngyd a e-bost gan Bleddy'n Rhys o Uned Archwilio Cyngor Gwynedd.

## **8..Adroddiad Cyng. Elwyn Evans , cynrychiolydd Un Llais Cymru.**

Cafwyd adroddiad gan Cyng Elwyn Evans am brosiect Argyfwng Costau Byw gan Un Llais Cymru er mwyn cynorthwyo Cynghorau Cymuned I gefngoi eu cymunedau.

LLANFIHANGEL Y PENNANT COMMUNITY COUNCIL

Minutes of a Council meeting held on Monday evening the 8th of April 2024 at 7.00pm in the Ganolfan, Abergynolwyn.

Present; Cllr. Emrys Thompson, Elwyn Evans, Robert D Jones, Gwynedd Roberts, Steve Lewis, Eleri Puw, Miriam Webb, Bethan Lawton (Gwynedd Council) and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Emrys Thompson.

Apologies were received from Cllr Dylan Jarman.

2. Expressions of interest were invited for issues on the agenda, and Cllr Robert Jones indicated an interest in the application from Meirionnydd Young Farmers' Clubs.

It was noted that there was no request to have presentations from members of the public on an issue on the Agenda.

3. The minutes of the meeting held on the 11th of March were confirmed on the proposal of Cllr. Gwynedd Roberts and seconded by Cllr Eleri Puw.

4. Matters arise

a) Highways/pathways issues - reference was made to the hedge that was overgrowing on Llanegryn Road, and there was confirmation that Gwynedd Council had written again to the owner of number 6.

The idea of making a path from the Heol y Dwr gate up to a bench in the Playground was discussed. Talyllyn Railway had offered to help with the cost. It was decided, following a vote, to ask for a price to get an idea of the cost in the first place. The Clerk would have a word with G L Jones, Playgrounds, Bethesda.

b) Talyllyn Railway - in relation to the slate wagon project, the response of Anna Lewis from Gwynedd Council was read which said that an application could be made under the LleCHI LleNi scheme - the lottery application. They would know if the lottery application is successful by the end of June. We went on to discuss whether it would be possible to

make an application through the Snowdonia Communities Fund, and the Clerk would contact the National Park in the first place, and then Anna Lewis.

c) A tree damaging a wall - there was no update, and this would be on the agenda next time.

d) The Council's asset list - the figure of £19114 was confirmed as in the last meeting minutes, adding £1 for the route between 1 Maesmeillion and Riverside Café.

## 5. Planning Matters

It was confirmed that there were no issues since the last meeting.

## 6. Finance Matters

### a) Invoices;

Agreed, on the motion of Cllr Robert Jones and seconded by Cllr Miriam Webb To pay the Council's insurance, which is £345.55. It was noted that all the papers had been sent out to the Councilors in advance, and it was confirmed that the cover was sufficient.

It was agreed, on the motion of Cllr Eleri Puw and seconded by Cllr Steve Lewis To pay the One Voice Wales Membership invoice for 2024-25 for a total of £94..

### b) Requests for money;

The Meirionnydd Young Farmers Clubs letter was discussed, along with the balance sheet that had been sent to the Councillors. Following a vote, it was agreed, on the proposal of Cllr Gwynedd Roberts and seconded by Eleri Puw to contribute £100. (a declaration of interest was received from Cllr Robert D Jones when this was discussed, and he had signed the form)

c) The correspondence from Audit Wales for the 2023-24 audit was outlined, along with an email from Bleddyn Rhys from Gwynedd Council's Audit Unit.

The 2023-24 accounts were officially presented to the Council by the Clerk. Reference was made to all the records, the finance documents and the summary, and it was confirmed that all was ready to be submitted to the internal Auditor in due course.

The Clerk referred to the Biodiversity Report he had prepared in draft, which he would send to the Councillors.

The balances were confirmed (8.04.24) namely General Account £6311.57 and Business Reserve account £18,538.98.

#### 7. Councilor Beth Lawton's report (Gwynedd Council)

Cllr Beth Lawton referred to a Well-being Grant of £500 which was available for local events, and which could be of help to the Ganolfan.

She confirmed that she had contacted the Highways Department regarding the hole (channel) in the road near Dolffanog. This had come up several times before, and there was now hope that it would be resolved.

A hole in the wall of the cemetery in Abergynolwyn needed to be investigated. Cllr Emrys Thompson said he would look into this.

#### 8..Cllr.'s Report. Elwyn Evans, representative of One Voice Wales.

A report was given by Cllr Elwyn Evans about the Cost of Living Crisis project by One Llais Cymru in order to assist Community Councils to support their communities. Feedback and opinions were needed on this, and they would hold 3 short workshops in April and Cllr Elwyn Evans would register.

It was also noted by Cllr Beth Lawton that Gwynedd Council was holding events with the subject of living costs in April, and she noted that it was unfortunate that there was no better collaboration.

#### 9. Correspondence.

The following correspondence was discussed;

- a) Llanfihangel y Pennant Church cemetery matters, a further email from Helen Edwards regarding the burial of her parents' ashes was noted - this had been discussed at the last meeting.
- b) It was also reported about a meeting held at the cemetery on the 12th of March, when the plan for the cemetery that had been prepared by Cllr Emrys Thompson was discussed. Emrys was thanked very much for his thorough work, and this would be of great help to the future.
- c) Correspondence was noted about 'Tai ar Daith' from Gwynedd Council, which is to raise awareness about various housing schemes, and details of events were given, which included Ty Siamas in Dolgellau on the 16th of May 3pm to 6.30. Cllr Beth Lawton said she would try to put the details on local websites.
- d) Information and details of the 'Eryri Communities Fund' were noted - the correspondence was from Anna Lewis Gwynedd Council.
- e) The details of the Urdd's opportunity fund for all were noted - and posters were placed in the Centre.
- f) Correspondence from Un Llais Cymru regarding a focus group of youth representatives of town and community councils was noted. Cllr Eleri Puw and Miriam Webb agreed to be part of this, and the Clerk would forward the details.
- g) The One Voice Wales Training Sessions information had already been sent to the Councillors. It was reminded that the plan is on a website

#### 10. Any other matter

- Work was needed on the road and on the pavement near the entrance to the Church, and the Clerk would deliver to Gwynedd Council.
- It was necessary to look at the flower pot which is under the sign near the entrance to the village of Abergynolwyn.
