- 1. Estynwyd groeso cynnes i bawb gan y Cadeirydd Emrys Thompson.**
Roedd ymddiheuriadau i law gan Cyng Bethan Lawton (Cyngor Gwynedd) a'r Cyng. Robert D Jones.

4. Materion yn codi

- Gwaith gyda HMRC – PAYE i'r Clerc.** Nodwyd fod Cwmni Evans & Owen, Dolgellau wedi derbyn y gwaith.
- Gwaith paentio ar offer yn y Cae chwarae** – roedd y Clerc wedi cysylltu gyda'r 3 a enwyd, ac roedd 2 wedi dod yn ol ato. Nid oedd tendrau eto i law, ac roedd rhaid atgoffa.
- Rheilffordd Talyllyn** – nid oedd unrhyw ddiweddarriad.
- Coeden yn difrodi wal** – nid oedd unrhyw ddiweddarriad.
- Gwefan i'r Cyngor** – trafodwyd cynnig i law i weinyddu y wefan gan HG Web Designs, sef cost cychwynol o £250, hefyd £150 am hostio'r www yn flynyddol a £100 y flwyddyn am ddiweddar ac ati. Penderfynwyd yn unfrydol i dderbyn hyn. Byddai angen lluniau a chyflwyniad byr i'r ardal.

Roddynt wedi eu newid i fod yn berthnasol l’r Cyngor, a chyfeiriwyd yn arbennig at y polisi tuag at defnydd o’r iaith Gymraeg. Ar gynnig Cyng Gwynedd Roberts a’l eilio gan Cyng Elwyn Evans roedd pawb yn unfrydol y dylid eu mabwysiadu.

Dyweddodd y Clerc fod angen mabwysiadu polisiau eraill cyn eu rhoi ar y wefan, gan gynnwys Polisiau Cyfle Cyfartal, Rhyddid Gwybodaeth, Amgylcheddol, Diogelu Gwybodaeth a Data, ynghyd a pholisi Pryderon a Chwynion. .

LLANFIHANGEL Y PENNANT COMMUNITY COUNCIL

Minutes of a meeting of the Council held on Monday evening the 9th of October 2023 at 7.00pm in the Ganolfan, Abergynolwyn.

Present; Cllr. Emrys Thompson, Elwyn Evans, Gwynedd Roberts, Eleri Puw, Steve Lewis, Dylan Jarman, Miriam Webb and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Emrys Thompson. Apologies were received from Cllr Bethan Lawton (Gwynedd Council) and Cllr. Robert D Jones.

Declarations of interest were invited for issues on the agenda, but no declaration was made.

2. It was noted that there was no request to have presentations from members of the public on an issue on the Agenda.

3. The minutes of the meeting held on the 11th of September were confirmed on the proposal of Cllr Gwynedd Roberts and seconded by Cllr Miriam Webb.

4. Matters arise

a) Cutting the grass of cemeteries and the playing field - it was noted the need to get new tenders for 2024. We would need 3 tenders, including one from Owain Williams. It would be necessary to notify in Dail Dysynni, the notice board and the website.

b) Burial costs - it was confirmed that the Council follows Gwynedd Council's costs, and the Council pays the person who opens a grave.

The Clerk noted that he had received an email from Steve Davies regarding the burial of the ashes of the late William Davies in Llanfihangel y Pennant Church on Saturday the 2nd

of December. He had dealt with this, and contacted Richard Griffiths regarding opening a grave.

Paperwork was received with the burial of the late JC Smith on the 3rd October. (payment of £522 received via BACS 25.09.23)

c) Work with HMRC – PAYE for the Clerk. It was noted that Evans & Owen, Accountants, Dolgellau had accepted the work.

d) Painting work on equipment in the Playground - the Clerk had contacted the 3 named, and 2 had come back to him. Tenders were not yet available, and they had to be reminded.

e) Talyllyn Railway - there was no update.

f) Tree damaging a wall - there was no update.

g) Website for the Council - an offer to administer the website was to hand by HG Web Designs, an initial cost of £250, also £150 for hosting the www annually and £100 per year for updating etc. It was unanimously decided to accept this. Pictures and a short introduction to the area would be needed.

h) Work contract for the Clerk - this had been prepared by the Clerk, and distributed to the Councillors. It was unanimously agreed to be accepted.

i) Heritage Site - It was noted that the last Slate Group meeting had been postponed. The Clerk noted that he had responded to Hannah from Gwynedd Council that the Council had decided not to go ahead with putting an additional plaque on the Centre, and this had been acknowledged.

j) Dog litter bin - the Clerk noted that he had contacted the warden and Galw Gwynedd after the last meeting, but it was still full. He had spoken further on the phone, and had been given a reference number for the case. It was suggested that we now wait 7 days. Cllr Gwynedd Roberts said he had a box full of sacks for our use.

k) Mari Jones information panels - the Clerk had responded to Nerys Siddall, but had not heard anything further.

5. Planning Matters

There was one request received since the last meeting, namely;

NP5/67/16G - Construction of an agricultural shed over the existing leaf store - Ty'n y Bryn, Llanfihangel y Pennant.

It was unanimously decided that the Council was supportive of the application. The Clerk would respond.

6. Finance Matters.

It was decided to pay the following;

Invoice Major & Evans, Accountants - work up to the end of August - £90.00

Owain Williams' invoice for cutting the grass of the Playground and Llan Cemetery - £680.

Richard Griffiths' invoice for opening the grave of late JC Smith - £50.

Clerk's remuneration for September £133.47 and HMRC £33.20.

There were two applications for money and it was decided as follows;

Abergynolwyn Eisteddfod - £150

Wales Air Ambulance - £200.

7. Councilor Beth Lawton's report (Gwynedd Council)

There was an apology from Cllr Beth Lawton this time.

8..Cllr.'s Report. Elwyn Evans, representative of One Voice Wales.

There were no meetings to report this time, and there was an apology from Cllr Elwyn Evans who was unable to attend the last area meeting on the 4th October. There was concern about the reduction in the number of people who had responded to the U LL Cymru Annual Meeting, and it had to be postponed.

9. Correspondence.

- An email was received from Jane Barraclough and the Tywyn Hospital Group, which contained some attachments. It was decided to invite her to the next meeting on the 13th of November.
- An email was noted from Ifan Llewelyn Jones on behalf of 'Hunaniaith', and that they are moving out of the control of Gwynedd Council from next April, and are known as 'Menfer iaith Gwynedd'

10. Councilor Training

The Clerk promised to send details of the latest courses around the Councillors, when they were received by Un Llais Cymru. It was confirmed that the Council would cover costs for Councilors to attend courses.

11. New Standing Orders and policies to be accepted.

A draft copy of new Standing Rules published by One Llais Cymru in 2023 had been circulated to the Councilors in advance. These complied with the latest legislation. They had been changed to apply to the Council, and particular reference was made to the policy towards the use of the Welsh language. On the motion of Cllr Gwynedd Roberts and seconded by Cllr Elwyn Evans, everyone was unanimous that they should be adopted. The Clerk said that other policies needed to be adopted before putting them on the website, including Equal Opportunity, Freedom of Information, Environmental, Information and Data Protection Policies, together with a Concerns and Complaints policy.

12. Any other matter

- A number of bodies and organizations needed to be updated with the Clerk's details, and this was in hand.
- It was noted that the Ganolfan can be booked for meetings by email to the future
