

## CYNGOR CYMUNED LLANFIHANGEL Y PENNANT

### Cofnodion o gyfarfod o'r Cyngor a gynhaliwyd Nos Lun y 10fed o Fehefin 2024 am 7.00yh yn y Ganolfan, Abergynolwyn.

Presennol; Cyng. Elwyn Evans, Miriam Webb, Robert D Jones, Gwynedd Roberts (o 7.50yh ymlaen) Steve Lewis, Eleri Puw, Emrys Thompson, Dylan Jarman, Cyng Bethan Lawton (Cyngor Gwynedd) a Huw T Jones (Clerc)

1. Estynwyd groeso cynnes i bawb gan y Cadeirydd Elwyn Evans. Gwahoddwyd ddatganiadau o ddidordeb am faterion ar yr agenda, a nododd Cyng Elwyn Evans a Cyng Beth Lawton eu diddordeb yn y cais am arian gan Dail Dysynni.
2. Nodwyd nad oedd unrhyw gais i gael cyflwyniadau gan aelodau o'r cyhoedd ar fater ar yr Agenda.
3. **Cadarnhawyd gofnodion y Cyfarfod Blynnyddol a gynhaliwyd ar y 13eg o Fai** ar gynnig Cyng. Miriam Webb a'l eilio gan Cyng Robert D Jones.

#### 4. Materion yn codi

- a) **Materion Prifyrdd/llwybrau** – adroddwyd y diweddaraf, a bod yr arwydd ar y ffordd ger mynedfa'r Eglwys yn Abergynolwyn wedi ei godi eto.

Roedd y Clerc wedi cael gair gyda G L Jones, Playgrounds, Bethesda, ac wedi dosbarthu y pris am wneud llwybr ar y cae chwarae, sef £4300. Gwelwyd fod angen pris arall gan Playquest, Flint. Byddai'r Clerc yn trefnu hyn.

- b) **Rheilffordd Talyllyn** – yng nghyflwr y prosiect wagen lechi, roedd Anna Lewis o Gyngor Gwynedd yn disgyl ateb erbyn diwedd Mehefin ar gyfer grant Cronfa'r Loteri.
- c) **Coeden yn difrodi wal** – nid oedd diweddariad.
- d) **Archwiliad y cae chwarae gan ROSPA** – roedd cadarnhad y byddai hyn yn digwydd yn fuan. Roedd y Clerc wedi cael neges gan Luke Genders ar y 14eg o Fai y byddai'r gwaith paentio yn cael ei gwblhau yn fuan, ond roedd siom fod hyn yn parhau heb ei wneud. Roedd angen atgoffa Luke Genders eto i gwblhau y gwaith paentio mor fuan a phosib.
- e) **Toiledau Abergynolwyn** – roedd y gwaith wedi ei gwblhau
- f) **Ciosg Cwm Llanfihangel y Pennant** – roedd y ciosg wedi ei drwsio.
- g) **Materion mynwent Llanfihangel y Pennant** – cadarnhawyd y cyswllt gyda Gwyn Evans o C T Evans (Cyfarwyddwyr Angladdau – Aberystwyth), a'r sicrwydd mai y Cyngor Cymuned fyddai yng ngofal dewis person i agor beddau yn y dyfodol.
- h) **Cod ymddygiad yn ddwyieithog** – roedd hyn i law gan Gyngor Gwynedd, ac wedi ei ddanfon i bob Cyngor ymlaenllaw.

#### 5. Materion Cynllunio

Cadarnhwyd nad oedd unrhyw faterion ers y cyfarfod diwethaf.

## 6. Materion Cyllid.

- a) **Cadarnhwyd derbyn £945** ar gyfer agor bedd I'r diweddar John Adrian Northern ym mynwent Llanfihangel y Pennant. Hefyd cadarnhwyd derbyn £100 o gyfraniad at fynwent yr Eglwys .Roedd y Clerc wedi danfon gair o ddiolch I'r teulu.
- b) **Nodwyd Cyfrifon 2023-24**, ac y byddai'r cyfan yn cael ei ddanfon I'r Archwilydd allanol maes o law. Nodwyd yr hysbysiad gyhoeddus i fynd ar yr hysbysfwrdd a'r wefan.
- c) **Nodwyd anfonebau Arwyn Davies am dorri gwair mynwentydd/ cae chwarae**, sef £500 am dorri ym mis Ebrill, (wedi ei leihau £180 yn dilyn peidio torri rhan o fynwnet yr Eglwys oherwydd blodau) a £680 am dorri mis Mai. Ar gynnig Cyng Emrys Thompson a'l eilio gan Cyng Miriam Webb, cytunwyd I dalu rhain.
- d) **Ceisiadau am arian;**

**Papur Bro Dail Dysynni** – darllenwyd llythyr I law, a chyfeiriwyd at y fantolen. Ar gynnig Cyng Steve Lewis a'l eilio gan Miriam Webb, penderfynwyd ar swm o £125. (Cafwyd datganiad diddordeb gan Cyng. Beth Lawton a Cyng Elwyn Evans a gadawsant yr ystafell pan drafodwyd hyn)

## 7. Adroddiad Cyngħorydd Beth Lawton (Cyngor Gwynedd)

Adroddwyd am y datblygiadau diweddaraf yn Ysgol Craig yr Aderyn. Hefyd rhagolygon am doriadau yng nghyllideb Cyngor Gwynedd y flwyddyn nesaf, a'r trafferthion yr oedd cyfyngiad Adran 106 deddf cynllunio yn ei achosi I deulu lleol.

Mynegwyd ein dymuniadau gorau I'r Cyng Beth Lawton ar ei thriniaeth o fewn y dyddiau nesaf.

## 8. Adroddiad Cyng. Elwyn Evans , cynrychiolydd Un Llais Cymru.

Cafwyd adroddiad gan Cyng Elwyn Evans am Bwyllgor Polisi a gynhaliwyd ar y 7fed o Fehefin, Cyfeiriodd at fygythiad o uno cynghorau cymuned yn ardal Penybontarogwr, a hefyd sefyllfa debyg yn Ceredigion. Gwelwyd fod rhaid bod yn effro I'r perygl o hyn ddigwydd. Nodwyd bosiblwydd fod Cyngor Gwynedd yn gofyn I Gynghorau Cymuned gymryd mwy o gyfrifoldebau yn y dyfodol.

Cyfeiriodd hefyd at bapur ar Fframwaith Llywodraethiant Un Llais Cymru. Byddai yn adrodd ymhellach ar hyn. Cadarnhaodd fod 92% o Gynghorau Cymuned yn aelodau o Un Llais Cymru.

## 9. Gohebiaeth.

- a) Roedd e- bost gan **Un Llais Cymru ynglyn a amserlen camau cyn etholiad**, a beth oedd yn berthnasol I'r Cyngor.
- b) **Gohebiaeth mynwent Eglwys Llanfihangel y Pennant**, - roedd e-bost gan Helen Edwards (cyfeiriad yn Llundain) yn gofyn caniatad i gladdu llwch eu diweddar rieni

mewn bedd newydd yn Llanfihangel y Pennant. Roedd hyn i ddigwydd ar Ddydd Sadwrn 14eg o Fedi. Byddai y Clerc yn ymateb yn dweud y byddai'r Cyngor yn trefnu i'r bedd gael ei agor.

- c) Roedd cadarnhad gan **Panel Annibynnol Cymru** (Llywodraeth Cymru) am raddfeydd cydnabyddiaeth ariannol Cynghorwyr am 2024-25.
- d) Roedd llythyr gan Ysgrifennydd Cabinet Llywodraeth Cymru Ken Skates ynglyn a mater cyfyngiad 20mya. Penderfyniad y Cynghorwyr oedd cadw i'r sefyllfa bresennol yn Abergynolwyn.

## **10 . .Ystyried y pwysigrwydd fod cwn o dan reolaeth yng nghyswllt y Cae Chwarae yn Abergynolwyn.**

Trafodwyd cwyn oedd i law yn y cyswllt yma, a'r honiad bod prinder llefydd gwyrdd ym mhentref Abergynolwyn I fynd a cwn am dro. LLANFIHANGEL Y PENNANT COMMUNITY COUNCIL

Minutes of a meeting of the Council held on Monday evening the 10th of June 2024 at 7.00pm in the Ganolfan, Abergynolwyn.

Present; Cllr. Elwyn Evans, Miriam Webb, Robert D Jones, Gwynedd Roberts (from 7.50pm onwards) Steve Lewis, Eleri Puw, Emrys Thompson, Dylan Jarman, Cllr Bethan Lawton (Gwynedd Council) and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Elwyn Evans. Expressions of interest were invited for issues on the agenda, and Cllr Elwyn Evans and Cllr Beth Lawton indicated their interest in the request for money from Dail Dysynni.

2. It was noted that there was no request to have presentations from members of the public on a matter on the Agenda.

3. The minutes of the Annual Meeting held on the 13th of May were confirmed on the proposal of Cllr. Miriam Webb seconded by Cllr Robert D Jones.

#### 4. Matters arising

a) Highways/pathways issues - the latest was reported, and that the sign on the road near the entrance to the Church in Abergynolwyn has been raised again.

The Clerk had a word with G L Jones, Playgrounds, Bethesda, and distributed the price for making a path on the playing field, which was £4300. Another price was needed, and contact with Playquest, Flint. The Clerk would arrange this.

b) Talyllyn Railway - in relation to the slate wagon project, Anna Lewis from Gwynedd Council expected an answer by the end of June for the Lottery Fund grant.

c) Tree damaging a wall - there was no update.

d) Inspection of the playing field by ROSPA - there was confirmation that this would happen soon. The Clerk had received a message from Luke Genders on the 14th of May that the painting work would be completed soon, but was disappointing that this remained undone. Luke Genders needed to be reminded again to complete the painting work as soon as possible.

e) Abergynolwyn Toilets - the work had been completed

f) Cwm Llanfihangel y Pennant kiosk - the kiosk had been repaired.

- g) Llanfihangel y Pennant cemetery matters - the contact with Gwyn Evans of C T Evans (Funeral Directors - Aberystwyth) was confirmed, and the assurance that the Community Council would be in charge of choosing a person to open graves in the future.
- h) Bilingual code of conduct - this was received by Gwynedd Council, and has been sent to all Councilors in advance.

## 5. Planning Matters

It was confirmed that there were no issues since the last meeting.

## 6. Finance Matters.

- a) Confirmed receipt of £945 for opening the grave of the late John Adrian Northern in Llanfihangel y Pennant cemetery. It was also confirmed a £100 donation received to the Church cemetery. The Clerk had sent a word of thanks to the family.
- b) The 2023-24 Accounts were noted, and that all would be delivered to the external Auditor in due course. The public notice was noted to go on the notice board and the website.
- c) Arwyn Davies' invoices for cutting grass in cemeteries/playgrounds were noted, namely £500 for cutting in April, (reduced by £180 following not cutting part of the Church cemetery due to flowers) and £680 for cutting in May. On the motion of Cllr Emrys Thompson and seconded by Cllr Miriam Webb, it was agreed to pay these.
- d) Requests for money;  
Papur Bro Dail Dysynni - a letter was read to hand, and reference was made to the balance sheet. On the motion of Cllr Steve Lewis and seconded by Miriam Webb, a sum of £125 was decided. (There was a declaration of interest from Cllr. Beth Lawton and Cllr Elwyn Evans and they left the room when this was discussed)

## 7. Councilor Beth Lawton's report (Gwynedd Council)

The latest developments at Ysgol Craig yr Aderyn were reported. Also forecasts for cuts in the Gwynedd Council budget next year, and the difficulties that the restriction of Section 106 of the planning act was causing to a local family.

Our best wishes were expressed to Cllr Beth Lawton on her treatment within the next few days.

## 8. Report of Cllr. Elwyn Evans, representative of One Voice Wales.

There was a report from Cllr Elwyn Evans about the Policy Committee held on the 7th of June, He referred to a threat of merging community councils in the Bridgend area, and also a similar situation in Ceredigion. It was seen that we have to be alert to the risk of this happening. It was noted the possibility that Gwynedd Council would ask Community Councils to take on more responsibilities in the future.

He also referred to a paper on the One Voice Wales Governance Framework. He would report further on this. He confirmed that 92% of Community Councils are members of Un Llais Cymru.

## 9. Correspondence.

- a) There was an email from Un Llais Cymru regarding the schedule of steps before an election, and what was relevant to the Council.
- b) Llanfihangel y Pennant Church cemetery correspondence, - there was an email from Helen Edwards (address in London) requesting permission to bury the ashes of their late parents in a new grave in Llanfihangel y Pennant. This was to happen on Saturday 14th of September. The Clerk would respond saying that the Council would arrange for the grave to be opened.
- c) There was confirmation from the Independent Panel for Wales (Welsh Government) about Councillors' remuneration scales for 2024-25.

d) There was a letter from Welsh Government Cabinet Secretary Ken Skates regarding the issue of a 20mph limit. The decision of the Councilors was to keep the current situation in Abergynolwyn.

10. Consider the importance of dogs being under control in relation to the Playground in Abergynolwyn.

We discussed a complaint received in this connection, and the claim that there is a shortage of green spaces in the village of Abergynolwyn to take dogs for a walk. It was discussed that there are clear signs in the Playground by the Community Council and Gwynedd Council, and that there is a very clear rule that dogs should not go on the Playground. It was decided to keep an eye on the situation, and that action would have to be taken if this happened again.

11. Any other matter

- Comments were noted that there is a shortage of parking spaces in the village of Abergynolwyn.
