1. Estynwyd groeso cynnes i bawb gan y Cadeirydd Elwyn Evans. Roedd ymddiheuriad gan Cyng Eleri Puw.

Aethpwyd ymlaen I dderbyn adroddiad blynnyddol gan y Cadeirydd Elwyn Evans am y flwyddyn 2024-25.

- b) **Rheilffordd Talyllyn /Safle treftadaeth** - nodwyd y drafodaeth gyda grwp LleChi Lle Ni yn gynharach yn y prynhawn ynglyn a'r arian a ddynodwyd i Abergynolwyn. Roedd penderfyniad i gael wagen lechi, ac roedd angen gwybod ble yn union i'w gosod, a'r union faint. Roedd angen gwneud cysllwt eto gyda Liz Porrett. Ni fyddai mwy o ymgysylltu gyda'r cyhoedd, ond roedd angen trafod digwyddiadau fel rhan o'r gwaith celf. Penderfynwyd gwahodd Jayne Mills i'r cyfarfod nesaf.

Minutes of the Council's Annual Meeting held on Monday evening the 12th of May 2025 at 6.00pm
in the Centre, Abergynolwyn.

Present; Cllr. Elwyn Evans, Steve Lewis, Emrys Thompson, Gwynedd Roberts, Robert D Jones, Miriam Webb, Dylan Jarman, Cllr Beth Lawton (Gwynedd Council) Huw T Jones (Clerk) and one member of the public.

1. A warm welcome was extended to everyone by Chairman Elwyn Evans. There was an apology from Cllr Eleri Puw.

An annual report was received from the Chairman Elwyn Evans for the year 2024-25.

He reported that the Council met on the second Monday night of every month (except August and December) and ensured that the taxpayers' money was spent effectively. The Council had responded to planning and financial issues as promptly and effectively as possible, and had responded to inquiries from the public as required. Detailed attention was paid to the Council's assets, especially the cemeteries, which were regularly supervised. The Playground had received detailed attention, with improvements made. There was detailed consultation with the Llechi Group locally, contact with Gwynedd Council, and the work continues.

He thanked Clerk Huw Jones very much for all his work during the year, and Cllr Bethan Lawton (Gwynedd Council) for her efforts helping with the work in every possible way. He also thanked all the Community councilors for their work and cooperation.

2. It was noted that there was no request to have presentations from members of the public on matters on the Agenda. One member of the public was present, but did not want to give any comments, but rather listen to the discussion.

3. The minutes of the meeting held on the 14th of April were confirmed on the proposal of Cllr. Emrys Thompson and seconded by Cllr Miriam Webb.

4. Matters arising

a) Highways/pathways issues.

Inquiries about routes were further discussed, and there would be a report at the next meeting. A number of stiles were noted to have been installed.

The response to the comment that there was a car on the Baciau road, near Jerusalem Chapel, and that it was on private land was reported in full.

b) Talyllyn Railway / Heritage site - the discussion with the LleChi Lle Ni group earlier in the afternoon regarding the money designated for Abergynolwyn was noted. There was a decision to have a slate wagon, and it was necessary to know exactly where to place it, and exactly how much. Contact needed to be made again with Liz Porrett. There would be no more engagement with the public, but events needed to be discussed as part of the artwork. It was decided to invite Jayne Mills to the next meeting.

c) Quality of water/sewerage - Abergynolwyn - a further response from Dwr Cymru dated 25th April was read. It was noted that a thank you was needed for the response, but that there was a further visit about 2 weeks ago, where it was confirmed that the bad taste continued.

d) Playground signs - an email from Emrys was reported, and a picture of two signs that need to be renewed. Cllr Beth Lawton promised to get a DIM BEICIAU; NO BIKES' and Cllr Elwyn Evans promised to get an estimate from a company in Dolgellau for a sign that needed updating - namely 'DIM CWN YN Y CAE CHWARAE; NO DOGS IN PLAYING FIELD'.

5. Planning Matters

There was one request received since the agenda was sent out, namely NP5/67/LB221A. Listed building permission to demolish an existing chimney, install trays to prevent tampering, and re-build the chimney using the existing materials at 4, Tany Bryn, Abergynolwyn. It was decided that everyone is supportive of the application as this is an improvement to the building, and uses local materials.

6. Finance Matters.

a) It was reported that the 2024-25 Accounts have now been through the hands of the internal auditor, and have now been returned without any queries. It was formally presented to the Councillors. It was confirmed that everything was complete to be passed on to the external

Auditor in due course. It was also noted that a public notice had been prepared to go on the website and the notice board in due course. .

It was also confirmed that the VAT claim for 2024-25 had been completed and delivered, and that the Clerk had reminded the HMRC Office that the payment for the VAT refund for 2022-2023 and 2023-24 had not been received.

b) Invoices; - on the proposal of Cllr Robert D Jones and seconded by Cllr Gwynedd Roberts, it was agreed to pay the following;

- RA Davies invoice for cutting the grass of the playing field and Llanfihangel y Pennant cemetery - £600. (there was a reduction of £80 due to not cutting where there were flowers)
- GL Jones Playgrounds invoice for work in the playground £6944.40.

(it was confirmed that the cheque for £346.97 for the Council's insurance had been presented since the last meeting, and that all the Councilors had received a copy of the policy, and that the 'cover' was sufficient)

c) Requests for money - the following was noted since the last meeting;

- Cymru Air Ambulance - it was noted that there was no development with the Judicial Review, and that it would have to be discussed next time.
- Marie Curie - it was decided not to contribute, because there was no activity locally from the charity.

7.Election of Officers 2025-26.

Chairman - on the proposal of Cllr Gwynedd Roberts and seconded by Cllr Dylan Jarman, it was unanimously agreed on the name of Cllr Elwyn Evans as Chairman for 2025-26, and Cllr Miriam Webb as Vice-chairman for 2025-26.

8. Clerk's Salary and Terms 2025-26

The Councilors were given the opportunity to have their own discussion in this connection. The same terms were confirmed for 2025-26, namely remuneration of £2000 and costs of £500. It was

noted that a figure of an increase in the payment should be agreed to be given in the budget for the year 2026-27.

9. To confirm the dates of the remaining meetings of Llanfihangel y Pennant Council for 2025-26.

It was agreed to meet on the second Monday in June, namely 9/06/25. At the request of the Clerk, it was agreed to consider a meeting on the second Tuesday night in the rest of the year, except in the months of August and December. It would have to be confirmed at the next meeting, with certainty that the Ganolfan would be available.

The Clerk would then confirm on the Ganolfan website and on the Council's website.

10. Register of interests forms were distributed to be completed by Councilors and were returned.

On the motion of Cllr Roebert D Jones and seconded by Cllr Steve Lewis, and with everyone's agreement, the following was adopted;

Code of conduct - hard copies available were noted.

Financial regulations and standing regulations

Risk assessment of the Llan a yr Fedw cemetery, together with the Playground and the Council's financial matters (which had been distributed in advance to the Councillors)

Asset register - which had been distributed in advance to the Councilors and the figure of £19115.00 was confirmed

The other policies were also adopted - concerns and complaints, equal opportunities, environmental, biodiversity, data protection and freedom of information (all of which are on the Council's website)

12. Councilor Beth Lawton's report (Gwynedd Council)

A report was received from Cllr Beth Lawton about her work in the area, referring to inquiries with the roads in the area, and also the latest with Ysbyty Tywyn.

13. Report of Cllr. Elwyn Evans, representative of One Voice Wales.

It was reported that the next Area Committee is on Wednesday 14th of May.

14. Correspondence.

a) Matters of Llanfihangel y Pennant cemetery - there was no further response from Ben Thomas following the last meeting.. A reminder was needed to ensure the correct protocol.

b) Un Llais Cymru training sessions were identified, and the Clerk would distribute them to the Councillors

c) The Clerk had been part of the National Park Communities Forum which met on the 8th of May, and the issues in question were reported.

d) Reported on a letter from the Chairman of Protection of Bronglais Services, and the proposed changes to the Stroke Unit. The Clerk would distribute it. There was a public meeting on 20th June.

e) There was correspondence from Gwynedd Council regarding the launch of the Community Regeneration Support Fund - the Clerk would distribute it.

f) Correspondence from RoSPA confirmed an inspection again this year at a cost of £80.

15. Any other matter

- It was agreed that the Community Council would do the tombola once again at the Carnival in Abergynolwyn on the last weekend of July.
