Chairman Emrys Thompson and Councilors Bethan Lawton, Gwynedd Roberts, Elwyn Evans, Robert Jones, Eleri Puw, Steve Lewis. Also Liz Porrett who is one of the two who have taken up the positions of Chief Executive of the Talylyn Railway as a result of the departure of Stuart Williams who has accepted a position on the Island of Orkney in Scotland.

Liz Porrett was introduced by Emrys.

There was a good discussion between the committee and Liz Porrett who agreed to work with us for the benefit of the area to expand the 'Llechi' tourism side and the railway.

We were looking to have a slate wagon placed on the edge of the village to indicate the importance of the industry to the area in the future. It was noted that there was no spare wagon in the railway and one would have to be built from scratch. This would be possible through volunteers to build one but the materials would have to be paid for. Price objective around £2000, and the majority would go on the costs of ordering the wheels

Liz wanted to emphasize that a copy of an original would have to be made as accurate as possible to the genuine article or some would be sure to notice. She thought it would be possible to look for grants for the project and it would be an idea to ask Anna to begin with.

Plans are underway to refurbish the 'Turn Table' at the top of the incline to the village.

They have also applied for a grant to obtain a building in order to display the Heritage Site story and the railway, to bring the story alive.

Liz Porrett was thanked for coming to discuss working together, She left before we got to the official agenda.

9. Chairman's report. Received an email approving the 2019/20 accounts by the external inspectors. Everything is fine. This needs to be advertised on the notice board RJ to sign a form from Gwynedd Council, that they take on the work of the internal audit.
10. Clerk's Report:- Emrys; Annual list of Council committee dates agreed
11. Budget:- Bill received from the Ganolfan regarding our meetings, need to be corrected and Emrys to go back to them.
12. Councillor Beth Lawton's report:- Gwynedd Council's work: Repair Dolamarch (Llwyn) bridge guidelines. 2. A fence on top of a wall near Ty Pridd Talyllyn.  
Distribution of pamphlets, Cartrefi Gwynedd (Homeshare) relating to and looking after elderly persons.  
Missed the last Health Board meeting but had a report that two new members of staff are going to be working in the minor injury section having finished training and the other member is having more time to recover after the accident. Intended to open before the summer. 'Out at Home Nursing' Towards home is working well and a new clinic which is changing 'dressings' etc seems to be working well. There are two cars to work out in the community and staff will share ward and community work when ward re opens.
13. Kiosk:- Groesffordd and Minffordd working. Nothing to report from Tynbryn as Liz Saville has replied saying that this is a matter for Cardiff and that Mabon ap Gwynfor would once again be asked to look at the matter, she has sent him an email.
14. One voiceWales :- Elwyn, policy committee on Friday but no notes at hand, report next time.
15. One Voice Wales:- Application to attend the One Voice conference. Mistake and ignore it.
16. Heritage Site:- Steve Lewis reports from the Center committee regarding the Slate sign. We need a letter from the center and also a letter of complaint from anyone before we can have a discussion on the subject.

17. Tombola:- for the Carnival, want volunteers and contributions. Everything to Miriam or the next committee.

18. Cherry tree damaging a wall and parking issues. It was suggested that we ask Arwyn and Owain for a price to cut? But it was agreed that this would lead to improvements for some to benefit, and the land on which the tree stands is not owned by the Council. Contact Edwin ( RJ ) to get more information regarding trees possibly on his property next o the river .....Parking near the Jerusalem chapel, it was passed that we go back to Mark Mortimer for an update.
